



W2G, 1099 or Win/Loss Statement Request Instructions

In order for Wind River Casino/Little Wind Casino to release this information, each patron is required to submit a signed "Win/Loss Statement and Tax Information Request Form". Only official request forms will be accepted for processing. Letters, telephone calls, or facsimiles will not be accepted.

Please note:

The tax statement request is only available for Rewards Club Card members and those individuals who had W2G or 1099 gambling winnings. Wind River Casino/Little Wind Casino does not track play that is not associated with a patrons rewards club card account, and it is possible to win or lose larger sums than our system records if you did not always use your Rewards Club card. For more information regarding the claiming and filing of gambling winnings customers are encouraged to contact the IRS or their tax advisor.

How do I get this form?

- Visit the Player Services at Wind River Casino or Little Wind Casino and request a form in person.
- Download the form from the <http://www.windriverhotelcasino.com> web site and follow these instructions.
- Call 1(866) 657-1604 and request that a form be sent to the customer (name & address required).

What information will need to be completed on the form?

- **Name** - First and Last name. (Print legibly) One form per person.
- **Social Security Number** - The social security # for the patron requesting the tax statement.
- **Mailing Address** - Current mailing address. To help us serve our customers, please verify that we have the most current mailing address.
- **City/State/Zip** - Complete city, state, and zip code information.
- **Telephone Number** - Current telephone number where the customer can be reached.
- **Rewards Club Card Number** - Current Rewards Club Card Number. There should be only one account per person.
- **Date of Birth** - The birth date of the person requesting the information. This allows us to verify the correct information.
- **Email Address** - This is optional for the customer.
- **Statement Request** - Indicate the gaming activity year(s) and the type of tax statement the patron is requesting. The "Win/Loss Statement and Tax Information Request Form" must be signed by the account holder in order to be processed.

Once the form is completed?

- **If the Rewards Club account holder is present at the Casino requesting a Tax Statement-** The Player Services Representative is required to obtain proper identification (Driver's License, Passport, Alien Registration, Military ID, Foreign ID, valid state, federal, or Tribal ID), to review the picture ID, signature and verify the patron's Rewards Card number, if applicable. The bottom portion of the form is to be filled out with the type of identification provided and signature of the Player Services Representative who verified the information.
- **If Account Holder does not present request in person, Account Holder's signature must be notarized-** This official form can be returned to the Player Services Center at either location or can be mailed to the address stated on the form. A facsimile of this request will not be accepted.
- **Please allow 10-14 business days to process.**
